<u>9. WARRANTY</u> :- The item shall be warranted to be free from defects in design, mat

erial and workmanship for a satisfactory operation during the warranty period. The bi dder shall warranty for prompt repair and / or replacement at site free of cost if any p art of the machine is found to be defective in design, material or workmanship during the warranty period. The warranty shall not apply to normal wear and tear of compo nent parts.

23.1 CONCILIATION:

Any dispute, question, claim or difference arising out of or concerning this tender/ contract between the parties shall be settled through mutual negotiation by the parties and parties shall make all endeavors to settle this matter amicably. In case such amicable settlements is not possible, the parties shall take r ecourse to the conciliation proceedings for resolving such dispute, question, claim or differences.

The Conciliatory Committee shall comprise of the following:

- (i) A nominee of NMDC Management- Member (Independent of the officer handling the case)
- (ii) A nominee of the Supplier/ Contractor Member (Independent of the officer handling the case)
- (iii) Head of Law/ Law officer of NMDC Member

The above committee shall conduct the conciliation proceedings in accordance with the provision of the Arbitration and Conciliation Act 1996. The venue of the conciliation shall be at Dantewada. The settlement so arrived at final conciliation shall be binding on both the parties and will not be called in q uestion before any court or forum whatsoever.

Reference to arbitration shall be made only when conciliation has failed.

23.2 Arbitration:

23.2.1. FOR ALL THE TENDERS OTHER THAN GLOBAL TENDERS

23.2.1.1 All disputes or differences which may arise between the Owner and Supplier/ Contractor in co nnection with this Contract (other than those in respect of which the decision for any person is expresse d in the Contract to be final and binding) shall, after written notice by either party to the other and to th e Executive Director of the NMDC Ltd, Bacheli Complex, Bacheli (who will be the appointing authority), be referred for adjudication to the sole arbitrator to be appointed as hereinafter provided.

23.2.1.2 The appointing authority will send within ninety days of receipt of the notice of arbitration a pa nel of three names of persons, not directly connected with work, to the supplier/ Contractor who will sel ect any one of the persons named to be appointed as a sole Arbitrator within 30 days of receipt of name . If the appointing authority fails to send to the Supplier/ Contractor the panel of three names, as afores aid, within the period specified, the Supplier/Contractor shall send to the appointing authority a panel of three names of persons who shall also be unconnected with the organization by which the work is exec uted. The appointing authority shall on receipt of the names as aforesaid select any one of the persons named and appoint him as the sole Arbitrator. If the appointing authority fails to select the person and a ppoint him as the sole Arbitrator within 30 days of receipt of the panel and inform the Supplier/Contract or accordingly, the Supplier/ Contractor shall be entitled to invoke the provisions of the Indian Arbitratio n and Conciliation Act 1996 as amended from time to time.

23.2.1.3 The arbitral tribunal shall give reasons for its award. Each party bear its own cost and the cost of arbitration shall be equally borne bythe parties. The award rendered in any arbitration hereunder sh all be final and binding upon the parties. The parties agree that neither party shall have any right to leg al proceedings concerning any dispute under this agreement other than to enforce or facilitate the exec ution of the award rendered in such arbitration.

23.2.1.4 The arbitration proceedings shall be conducted in accordance with the Arbitration and Conciliation Act 1996 as amended from time to time.

23.3.1

23.3.1.1. Arbitration between a Central Public sector undertaking of the Government of India (not under the Ministry of Steel) and the Employer shall be as per the guidelines of Ministry of Heavy Industries and Public Enterprises, Government of India.

23.3.1.2. Arbitration between a Central Public Sector Undertaking of the Government of India under the Ministry of Steel, Government of India and the Employer, shall be as per the guidelines of the Ministry of Steel.

23.4. The further progress of any work under the contract shall unless otherwise directed by the Owner/ Engineer continues during the arbitration proceedings and no payment due or payable by/ to the Owner shall be withheld on account of such proceedings. It shall not be open to arbitrator to consider and deci de whether or not such work shall continue the arbitration proceedings.

23.5. The laws applicable to the Contract shall be the laws in force in India. The Courts of Dantewada, C hhattisgarh (State) shall have exclusive jurisdiction in all matters arising under this Contract.

- **15. LIMITATION OF LIABILITIES:** Except in cases of criminal negligence of will full n on- performance or will full default,
 - a. The supplier/contractor shall not be liable to the employer, whether in contr act, or otherwise for any indirect or consequential loss or damage, loss of pr oduction, loss of use, or loss of profits or interest costs.AND
 - b. The aggregate liability of the supplier/contractor to the employer, whether under the contract, in tort or otherwise including the cost of repairing or rep lacing defective equipment's, shall not exceed the 100% (hundred percent) of the contract price plus escalation if applicable as per contract, provided t hat this limitation shall not apply to any obligation of the contractor to inde mnity the employer with respect to copyright, patent infringement, workme n compensation and statutory liabilities in general that the employer may b e required to additionally bear due to default of the supplier/contractor.
- 16. FORCE MAJEURE CLAUSE :- If at any time during the continuance of Acceptance of Tender (A/T), the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reason of any war, hostility, acts of public enmity, civil co mmotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions or other acts o f God, provided notice of the occurrence of any such event is given by either party to the othe r within TWENTY ONE DAYS from the date of occurrence thereof, neither party shall, by reason of such event, be entitled to terminate the contract., and neither party shall have claim for d amage against the performance, and deliveries in such cases shall be resumed as soon as pr acticable after such an event has come to an end or has ceased to exist.

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
